# **Great Wolf Lodge – Test Guidelines**

## **Step 1: Prepare for Shop:**

- You will be making some required time observations. Please make sure to wear a watch with a second hand.
- You MAY NOT have children with you during these shops. If you want to, you may take one adult guest with you to sit with you during the sit down meal. You can place the order for one meal, conduct the shop in its entirety, reveal the shop, then leave your guest there to eat and finish the meal while you conduct the rest of the shops. Note that there are two sit down meals at the lodges.
- Please carry a bag with you to the lodge, so that you can carry the prizes and mystery shop paperwork out of the view of the lodge employees.
- You will be required to perform ALL THREE or FOUR mystery shops in one lodge visit (depending on the lodge). In order for all of the information to stay fresh in your mind, please print copies of the survey before your mystery shop assignment. Please BE DISCREET and, after each shop, find a secluded spot (such as the restroom) to note observations before moving on to the next shop assignment. Please make sure to **note the time that the mystery shop occurred, as well as the server's name/description**.
- Receive delivery of shop materials via FedEx. <u>FedEx will NOT deliver to PO Boxes</u>. You must have a physical address (listed in your Compass profile) and you must be home to sign for the package. Since you will be assigned multiple mystery shops to be conducted in one day, all of your materials for that day's worth of shops will arrive in the same FedEx package.
- > You MUST update your profile with the correct shipping address.

#### For EACH SHOP, you will receive:

- o (1) \$25 Coca-Cola Gift Card. This will be given to the successful CASHIER/SERVER.
- (1) Congratulations Certificate (will be given to the stand supervisor/manager for <u>successful</u> shops)
- o (1) Oops Card (will be given to the stand supervisor/manager for unsuccessful shops)
- o (1) Prize Confirmation Form (will be signed by the stand supervisor/manager for successful and unsuccessful shops)

### For EACH LODGE'S worth of shops, you will receive:

- o (1) Return Envelope with return FedEx label (complete top portion of the return label when returning prizes)
- (1) Confero Return Packing Invoice (will be used when returning unused prizes)
- (38) \$5 Coca-Cola Gift Cards. These will be given to the Supervisor/Manager to give to the employees on duty at the successful locations. The 38 cards are for ALL FOUR shops, to be divided among the employees on duty on at the time of the shop.

## Lodge Configuration – Getting into the Water Park:

Each lodge is set up differently. All of them will have restaurants or snack bars that are accessible from the lobby that you can get to without being a guest of the lodge. You will be able to shop these locations without a pass. You can take a guest and leave them in the restaurant to eat the meal after you have conducted the shop, then you can move on to the other shops. There will be ONE location that requires a pass into the water park. You will go to the front desk and said "I am with Coca-Cola and there is a wrist-band here for me." You take that wrist-band and go into the water park to shop the one snack bar that's in the water park. This is just a snack bar, so should only take you ten minutes, max, to conduct the shop and do the reveal. You must get in and get out, you are NOT allowed to stay and play and you will not be allowed a pass for the one adult quest you take for the other restaurant shop.

YES – we know that they may "rat you out" as the mystery shopper. Just go with the flow and pretend you aren't ©

## Step 2: Conduct Shop:

You must REVEAL the mystery shop as soon as you conduct it! As soon as you have completed the shop and paid for everything, ask to speak with the supervisor/manager on duty for that location and reveal the shop immediately. Do not wait to conduct all shops before revealing them. Again, we know the employees might warn the others that you're the mystery shopper.... Just go with the flow. Great Wolf is aware of this and we can just pretend you aren't at each location until you reveal that you are ©
